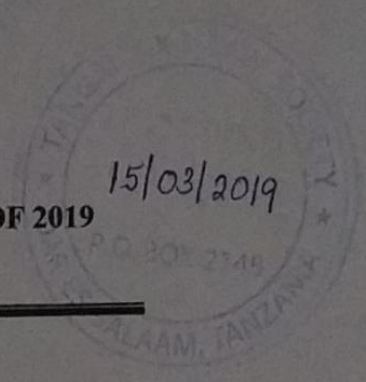

**TO: ALL MEMBERS OF THE TANGANYIKA LAW SOCIETY AT THE ANNUAL GENERAL MEETING TO BE HELD IN APRIL, 2019.**

**WHEREAS:** Tanganyika Law Society is entitled to statutory revenues;

**WHEREAS:** The said statutory revenues for three consecutive years were not indicate as Sources Revenue on Annual Budget of Tanganyika Law Society of 2016, 2017 and 2018 and it most likely that such statutory revenues have not been indicated on Annual Budget of Tanganyika Law Society of 2019;

**NOWETHEREFORE,** I wish to present this motion before the Annual General Meeting of the Tanganyika Law Society, in April, 2019, in the following terms:-


- (1) That Annual General Meeting of Tanganyika Law Society deliberates deeply and widely on matters concerning statutory revenues to which the Tanganyika Law Society is entitled.
- (2) That Annual General Meeting of Tanganyika Law Society is invited to form **the Special Committee of Inquiry** to probe or inquire into statutory revenues to which the Tanganyika Law Society is entitled.

(3) The said Special Committee of Inquiry on statutory revenues to which the Tanganyika Law Society is entitled should prepare the Report and submit same to next Annual General Meeting of 2020 for deliberation and making decisions on matters concerning statutory revenues to which the Tanganyika Law Society is entitled.

(4) That Annual General Meeting of Tanganyika Law Society pass necessary and important resolutions to facilitate said Special Committee of Inquiry to perform its functions and exercise its power smoothly and effectively.
